Issues may include: Nuclear, Biological and Chemical Weapons; Genetic Engineering; The Human Genome Project; Climate Change.

Relevant Criterion: The need to acquire experience is the more relevant criterion than past teaching experience in respect of this posted position.

Brief description of duties: Design course syllabus; lead lectures and discussions; prepare and mark graded assignments; respond to student emails in a timely and courteous fashion; schedule appointments when necessary and hold office hours; submit grades in a timely fashion.
