Course Description: This course can concern topics of special interest in the history of science from Antiquity until present. Topics may focus on specific-time periods, fields of inquiry, individuals, scientific institutions, or geographic locations.

Relevant Criterion: The need to acquire experience is the more relevant criterion than past teaching experience in respect of this posted position.

Brief description of duties: Design course syllabus; lead lectures and discussions; prepare and mark graded assignments; respond to student emails in a timely and courteous fashion; schedule appointments when necessary and hold office hours; submit grades in a timely fashion.
