## B. **ACADEMIC HISTORY**

### 6. i. Research Endeavors

My research examines the development of the social, psychological, and behavioral  
 sciences in various contexts, i.e., intellectual, biographical, disciplinary, political,

institutional, funding, etc. Most of my work concentrates on the period since World War Two, especially the Cold War era. I am particularly interested in the following issues: scientific boundary work for the social, psychological, and behavioral sciences; controversy over their intellectual foundations, normative implications, scientific identities, and socio-political uses; the evolution and impact of private and public patronage for research in these fields; debates about their social relevance and public policy uses.

Recently, I've begun to do research on the histories of vegetarianism and veganism, including their many important connections to the histories of science, technology, and medicine. At this early stage, I'm especially interested in exploring the development and current status of the three main pillars of modern veg\*ism: animal welfare and ethics, human health impacts for individuals and communities, and environmental issues and climate change. I'm exploring the intersection of those major umbrella issues with other important matters concerning gender, race, class, food security and justice, religion, law, social identity, nation-building, empire, colonialism, sports, and human rights. The largely unknown but rich history and significant impact of veg-ism in the Canadian context, including the history of the Toronto Vegetarian Association, is also of particular interest.
